# The Automation Wave

**70%**

The role must shift from process compliance to **high-latency human judgment**.

# The Value Equation

*Sys 2 > Sys 1*

As AI (System 1) commoditizes execution, the value of deliberate Human Judgment (System 2) skyrockets.

## THE FRAMEWORK

# Principle 1: Organizational Neuro- Coaching

Objective: Mitigate the team's 'Threat Response' to restore innovation.

---

**ACTION:** Use the Daily Scrum to diagnose 'Cognitive Friction'.

**MANDATE:** Tie leader evals to the **Silence Index**.

## THE FRAMEWORK

# Principle 2: Leading Predictive Governance

Objective: Transition from lagging reporter to leading risk governor.

---

**ACTION:** Utilize AI to identify 'dark debt' and high-risk patterns.

**MANDATE:** Halt releases based on **Risk Burn-up**.

## THE FRAMEWORK

# Principle 3: Agentic Workflow Orchestration

Objective: Manage the Human-Agent handoff, not just people.

**ACTION:** Reserve high-stakes decisions for System 2 intervention.

**MANDATE:** Architect workflows for **Correctness**, not just speed.
